What is this product?

Type

This product is a closed-ended investment company, incorporated as a public limited company in England and Wales. The Company has investment trust status. The Company's Shares are listed and traded on the London Stock Exchange.

Objectives

The Company aims to generate capital growth by investing in a global portfolio of healthcare stocks spanning the pharmaceutical, medical services, medical devices and biotechnology sub-sectors. The Manager may use financial derivatives (complex instruments based upon the value of underlying assets) to help achieve the Company's investment objective and to manage exposure to risk.

Intended investor

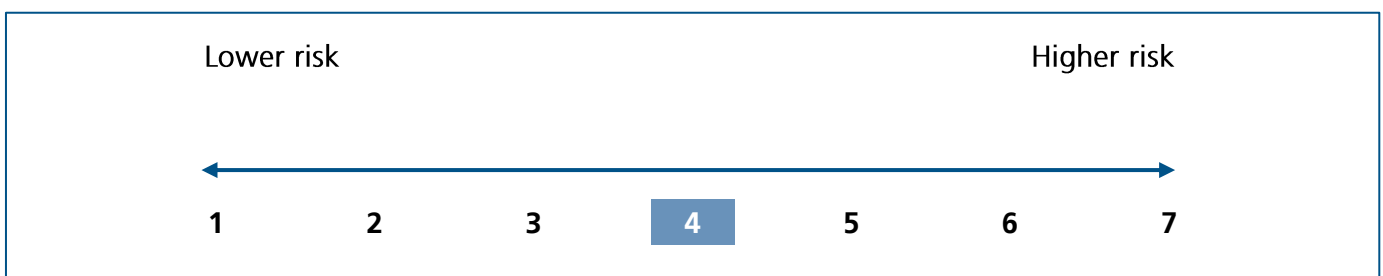
Shares in the Company are offered to investors who are prepared to risk their capital up to the amount invested in the fund. Investors should be prepared to stay invested for the long term. Shares in the Company should be held as part of a diversified portfolio of investments.

Term

At the first Annual General Meeting of the Company to be held after 1 March 2025, a special resolution to place the Company into voluntary liquidation shall be proposed to shareholders.

What are the risks and what could I get in return?

The summary risk indicator below is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets.



The risk indicator assumes you keep the product for five years. The actual risk can vary significantly if you sell your Shares at an early stage and you may get back less than you invested. You may not be able to sell your Shares easily or you may have to sell at a price that significantly impacts on how much you get back.

We have classified this product as 4 out of 7, which is classed as medium risk. This rates the likelihood of losing money in the future, based on historic prices, as medium. What are the costs?
